Completion of the entire **two-day** course fulfills the following training requirements:

- \* **OSHA "Competent Person" - federal requirement** for work involving removal and/or the disturbance of Class II asbestos-containing roofing materials (shingles, BUR, etc.).
- \* **Florida Asbestos Abatement Laws** training requirement for **"On Site Roofing Supervisor"** who must be present for work involving removal and/or disturbance of Class II asbestos containing roofing material **(F.S. 469.004(3))**.

**Extra Bonus:** Full course completion earns 16 hours of Continuing Education for Florida registered or certified contractors and meets State requirements for Workplace Safety Training and Business Practices.

Completion of the **first day only** fulfills the following requirements:

- \* **OSHA initial 8-hour course requirement** for all employees involved in the removal and/or disturbance of Class II asbestos-containing roofing materials, OR
- \* **OSHA 8-hour Annual Refresher** training for all employees working with Class II Asbestos Containing Roofing Materials (F.S. 469.004 (3)). Attendees must have previously completed FRSA's Two-Day Asbestos Training Course.
